LEGISLATIVE CORNER

NATION:

President Donald Trump's declaration of a national emergency on the southern border was designed to bypass congressional funding approval for his border wall and avoid the embarrassment of not living up to his most prominent campaign promise. Now, the President is scrambling to ensure that the Republican led Senate does not vote with Democrats to overturn his declaration for the first time ever. Even if he is rebuked by Congress, the President will veto the bill and take his chances in court.

CONNECTICUT:

The Public Safety & Security Committee voted to draft two pieces of legislation aimed at casino expansion. HB 7055, establishes an open-bidding process for a new casino while, SB II, would ease the way for the construction of a tribes-operated casino in East Windsor. The tribal casino is contingent on approval by the Department of the Interior which has failed to issue a ruling. The Committee also voted to draft SB I7, authorizing sports wagering, internet gambling and internet Keno, and SB 665, which would establish competitive sports wagering on certain sporting events.

MAINE:

Solar power advocates are pushing lawmakers to revive incentives for homeowners and eliminate a policy they say penalizes solar energy producers. They want the Legislature to fully restore the "net metering" policy that allows homeowners to receive credits on their utility bills for excess electricity fed back into the power grid. But they are also hoping lawmakers will eliminate a "gross metering" policy that requires homeowners to install an additional meter – paid for by all ratepayers – to monitor the output of solar panels.

MASSACHUSETTS:

With a new legislative session, there is always a flurry of bill filings. New this year is a bill similar to other initiatives passed in California and liberal cities. S.1957 An Act Increasing Solar Rooftop Energy would require all new construction to be built with the ability to accept solar rooftop panels. This would affect the codes regarding roof strength, angle, and other factors to enhance solar production. With few cosponsors, this is a long shot, but still a bill to watch.

NEW HAMPSHIRE:

A bill to legalize marijuana in New Hampshire was recently approved 209-147 by the state House of Representatives. The legislation would allow adults 21 and older to possess, gift, consume, cultivate and purchase certain amounts of cannabis from licensed retailers. A governor-appointed commission would be responsible for approving and issuing licenses for commercial marijuana cultivators, product manufacturers, testing facilities and retailers under the bill. A separate panel would solicit public and expert input on the legal market in order to inform the commission.

NEW JERSEY:

Governor Phil Murphy signed into law AB 3666 which requires all contractors working on a public project to have employees actively participating or who have completed a registered apprenticeship program. The act

becomes effective April 30, 2019 and effectively creates a huge barrier of entry for small contractors and non-union companies who do not have the established apprenticeship programs of their union counterparts.

NEW YORK:

Gov. Andrew Cuomo is hearing opposition to his support for expanding prevailing wage beyond public construction. Related legislation is in committee in the state Senate (\$1947) and in the Assembly (\$A1261\$). These bills seek to expand the definition of public construction to include private properties leased to public entities and properties designed at the expense of public entities. Critics argue that this will raise the cost of construction, while supporters say that privately owned properties leased back to public entities are skirting the original intention of prevailing wage laws.

PENNSYLVANIA:

Pennsylvania lawmakers introduced HB531 designed to enable the development of community solar projects, which will expand consumer access to affordable clean energy and increase jobs in the state's new energy economy. Currently, only a small percentage of Pennsylvanians have access to solar because they rent, live in multi-tenant buildings or live in homes that are unable to host a solar system. If approved, HB531 would give more Pennsylvanians a way to go solar by participating in a community solar installation located somewhere else in their community and receiving a credit on their utility bill for their share of the power produced.

RHODE ISLAND:

A Rhode Island solar siting bill HB 5789 had a hearing on March 14. The bill contains incentives to encourage solar development, requires a statewide renewable energy plan, defines areas of environments concern, prohibits state renewable energy programs to fund solar projects in areas of environmental concern among many other items. It is considered a catchall to allow for more uniform codes of local regulations to enhance solar development in a state sensitive to climate change and eagerly embracing renewable energy.

VERMONT:

The State Senate signed off on a bill that would raise Vermont's hourly minimum wage incrementally until it reaches \$15 in 2024. The current state minimum wage is \$10.78 per hour and is tied to inflation. \$.24 is on its way to the House of Representatives. This legislation would make Vermont like nearly every other New England State excluding New Hampshire which still does not set a state mandated minimum wage.
